How can a new supply chain management integration center help identify foreign dependency risks?

The Under Secretary of Defense for Acquisition and Sustainment, through its new Supply Chain Risk Management Integration Center, should identify resources, priorities, and time frames for integrating and sharing supply chain information across DOD that can help identify foreign dependency risks. (Recommendation 1)

Which DoD organizations are involved in foreign sourcing?

Should DOD require suppliers to provide foreign dependency information?

Unless DOD tests the costs and challenges of requiring suppliers to provide foreign dependency information, it could be missing an opportunity to address a mounting challenge to the security of its supply chains. How did the Defense Logistics Agency collect supplier data?

The Defense Logistics Agency used a third-party company to survey 63 suppliers across three classes of goods to collect supplier data. The suppliers provide aviation parts, clothing and textiles, and land and maritime parts.
