What is New York state's energy storage plan?

New York State aims to reach 1,500 MW of energy storage by 2025 and 6,000 MW by 2030. Energy storage is essential for creating a cleaner, more efficient, and resilient electric grid. Additionally, while the most recent retail energy storage incentive available through the New York state is accounted for by projects currently in development, it is anticipated that a new lower block of incentives will be made available, specifically for ESS projects in NYC.

What is New York's energy storage goal?

New York's Climate Leadership and Community Protection Act (Climate Act) codified a goal of 1,500 MW of energy storage by 2025 and 3,000 MW by 2030. In June 2024, New York's Public Service Commission expanded the goal to 6,000 MW by 2030.

A new bill, Energy Storage Tax Incentive and Deployment Act, was introduced in March 2021 for standalone ESS and offers similar tax credit benefits for certain renewable energy sources.
