Who owns the first solar plant in Oman?

Equity stake owned by Nebras Power Amin Renewable Energy Company owns the first utility scale solar plant in Oman, Amin IPP solar plant. Amin IPP has a total capacity of 125 MW. The plant started its commercial operation in Q2 2020.

Which countries are developing a 100 MW solar project in Oman?

In February 2019, a consortium led by Japan's Marubeni signed a power purchase agreement (PPA) with PDO Oman to develop a 100MW PV solar project at Amin. In March 2019, a consortium of Saudi and Kuwaiti firms secured financing for the 500 megawatt (MW) solar photovoltaic (PV) independent power project (IPP) at Ibri in Oman.
