Are solar panels tax deductible?

Solar Tax Credit: Homeowners receive a credit on their state taxes for 25% of solar panel installation costs, up to \$5,000. **Sales Tax Exemption:** Homeowners pay no sales tax on solar installations. **NY-Sun:** State-level program offering various incentives and income-targeted programs through its contractor network.

Do solar panels reduce taxable income?

For example, if your solar panel installation costs \$15,000, you can reduce your annual taxable income by \$4,500. What the federal solar credit includes: Keep in mind the federal tax credit only applies to purchased solar systems for first or second homes.

Which states offer solar incentives?

Arizona, Hawaii, Massachusetts, New Mexico, New York, South Carolina and Utah offer personal tax credits to encourage solar installations. Other states, like Tennessee, West Virginia and Oklahoma, don't have any residential solar panel incentives at all. **NOTE:** Solar program statuses often change with new laws or funding.
